This programme of clubs, led by qualified coaches and instructors from local providers, is a valued aspect of our school's provision and is a major feature of our commitment to providing a high-quality PE and sport experience for all of our pupils regardless of their individual needs or circumstances.</li> </ol>	<ul> <li>Ed Start and Your trust to provide Multi Sports Coaching to provides additional provision for after-school activity throughout the year. <ol> <li>Use funding to secure membership of local sports associations and bodies. This provides access to a wide range of competitions and festivals which broadens the experience of competitive sport that our pupils receive.</li> </ol>	<ul> <li>Ensure subscriptions to Heywood Schools Sports Association (£400) and Rochdale Borough School's Sports Partnership (£700) are paid on time.</li> <li>Use membership for training sports leaders throughout school.</li> </ul>
<ol> <li>Identify training needs for PE staff and provide access to available professional development within the borough and beyond.</li> </ol>	<ul> <li>Keep up to date with training offered by RBSGP and utilize as appropriate. Through this, we have accessed a gymnastics teacher training course for Simon Riley, swim support teacher training for Lauren McQuaid and introduction to quidditch training for Simon Riley and Thomas Callaghan.</li> <li>Additionally, TC and SR attended a sports conference held by RBSGP in order to keep up to date with initiatives and teaching updates. ## Intended actions for 2024/25

4. Continue to use the P.E. passport as an assessment tool for children in their P.E. lessons. Additionally, the system will be used for lesson plans for teachers. Finally, it will be a tool used to collate data on after school clubs and out-of-school events.

- 5. Buy equipment so that our children have the relevant resources so that children can be taught to a high standard.
- 6. To use specialists dance teachers to provide dance lessons across the school, to ensure curriculum coverage.
- 7. To provide new sports kits for the children to wear when representing the school at events and matches.
- 8. Repair of sports and playground equipment.
- 9. Quidditch equipment to allow us to implement a new sport throughout school. Provided by Enrich Education.
- 10. Orienteering equipment and staff training. The equipment is to be used for Outdoor Adventurous Activities in P.E. as well as being used for cross-curricular purposes across the whole school. Provided by Enrich Education.
- 11. Specialist afterschool sports provision and competition management and entry from specialist sports coach.
- 12. Additional Y6 swimming

- The P.E. passport is accessible to all teachers and they will/have been trained on how to access it and use it for lessons when the need arises. (£300 annual subscription)
- The P.E. passport has been/is used to collate data on a termly basis for information regarding after school clubs and out of school events. We also use the tool to identify those children who have perhaps not been given the chance to access these sporting opportunities previously.
- PE coordinator and teacher to constantly replace equipment as and when needed.
- Pupils receive high quality teaching in dance, improving pupil's fitness, agility, coordination, communication and teamwork skills. This will be done through Kats Dance Academy. (£1700)
- New Team kits will be purchased to replace the old kits some of which has been lost or misplaced.
- Equipment to be repaired as and when needed (£200)
- The equipment has been bought and there are plans to introduce quidditch in our P.E. lessons. (£1000)
- The equipment has been bought, and staff have been trained in how to use it. (£2500)
- Specialist Coach £12 000
- Catch up swimming £500
